The Alaska Federation of Natives International, Esk-Ind-Al, and the 13<sup>th</sup> Regional Corporation are all organizations which were a result of the court decision in the case United States vs. Tlingit & Haida Indians of Alaska in favor of the Tlingit & Haidas.
